

## General

ADM Investor Services BV (ADMIS BV) facilitates trading in futures contracts for agricultural commodities. ADMIS BV's clients include private individuals, traders, and processing industries. ADMIS BV is a private limited company licensed by the Netherlands Authority for the Financial Markets (AFM) and is [registered](#) as an investment firm in the register referred to in [Article 2:96 of the Financial Supervision Act \(Wet op het financieel toezicht, Wft\)](#). This licence permits ADMIS BV to provide investment services as defined [in Article 1:1 of the Wft](#), specifically elements (a) and (b).

The licence grants ADMIS BV the right to receive and transmit client orders and to execute orders on behalf of clients ("execution only"). ADMIS BV exclusively handles investments on behalf of its clients and does not act on its own account. For cross-border services, ADMIS BV operates under a European Passport.

## Organisation

ADM Investor Services International Limited (ADMISIL) is a wholly owned subsidiary of Archer Daniels Midland (UK) Limited and is indirectly a wholly owned subsidiary of the Archer Daniels Midland Company (ADM).

## Management

The board is responsible for the day-to-day operations of ADMIS BV, including devising and executing strategy, financial administration, and reporting. The board is also accountable for implementing a controlled risk management policy.
